II. CORRESPONDENCE/ANNOUNCEMENTS

Mr. Gerth submitted article titled 'Suggested Trees for Monmouth County' for the January 2014 Shrewsbury Community Newsletter. STC discussed future topics. One topic is STC authority and related ordinances. STC members will consider other topics. Newsletter deadlines in 2014 are March 10, June 10, September 10, and December 10.

III. <u>NEW AND UNFINISHED BUSINESS</u>

A. STC Organization

- STC welcomes Mike De Nofa to STC as council liaison. Mr. De Nofa also serves as liaison to the Department of Public Works (DPW) thus providing a useful link between STC and DPW.
- STC reaffirmed Mr. Gerth as chair for 2014.

- Mr. Gerth pointed out that the Borough Charter for STC allows for the appointment of a Secretary. He asked members to help define this role and consider filling it.
- B. Tree/Shrub Trimming Permit Asplundh Trees Mr. Gerth described steps taken before/after signing trimming permit. He visually inspected site specified in the permit. He called Asplundh Trees to clarify scope of work and to inquire about on staff Certified Tree Expert. During call he reinforce the importance of doing quality work and that the Borough will do follow-up inspections. Mr. Gerth then learned from Kathy Krueger (Borough Clerk) that copy of signed permit will be forwarded to DPW. Mr. De Nofa will follow-up with DPW to see what steps they now take.
- C. Tree Cithy USA Recertification application due 1/30/2014. Mrs. Preissler will contact Mr. Wentway at DPW for revised shade tree related expenses in 2013. Mr. Gerth will integrate into application and submit.
- **D.** Community Forestry Management Plan (CFMP) Annual Accomplishment Report accomplishment report due 2/15/2014. Mr Gerth will prepare draft for review by STC prior to next meeting.
- **E. Shrewsbury Borough Tree Ordinances Review** agreed that STC members will review prior to next meeting. Agreed to review at next meeting.
- **F. 2014 Tree Planting Wish List** Mr. Gerth informed STC that a tree for the Karalewich residence (36 Trafford) is on 2014 Spring Tree Planting Wish List. STC is accepting new requests for 2014 spring and fall planting.
- **G. Project Ideas for 2014** Mr. Gerth suggested STC take on a project for 2014. A couple of preliminary ideas discussed. STC members will bring ideas to next meeting.
