ORDINANCE NO. 1031 – SECOND READING/PUBLIC HEARING: Ordinance to Amend the Code of the Borough of Shrewsbury by Amending Chapter 170, Parks and Recreation Facilities

Open Meeting to the Public on Ordinance No. 1031

Councilman DeSalvo motioned to open the meeting to the public, seconded by Councilman Anderson, and approved by all Councilmember's present.

Close Meeting to the Public on Ordinance No. 1031

Seeing no one from the public wishing to speak, Councilman Moran motioned to close the meeting to the public, seconded by Councilman Anderson, and approved by all Councilmember's present.

Councilman Moran stated that the fees for tennis court usage were used to defray the cost of yearly maintenance and asked if that fact had been discussed in his absence. Councilman DeSalvo explained that the fees collected were minimal and that the Borough received multiple complaints about the cost.

Administrator Report

Mr. Seaman informed the Council that they had a copy of the Best Practices Survey he had prepared for the Borough in their meeting packet. He explained that the number of questions had been reduced this year from fifty to thirty and that the Borough answered twenty-seven with either 'yes' or 'not applicable'. He noted that the state requirement to continue state aid is that twenty-two be 'yes' or 'not applicable'.

Mr. Seaman stated that his office is going to add another option to allow residents to sign up for the Borough's newsletter and other community updates. Councilman DeSalvo suggested that the Borough spread the word at the Shrewsbury Classic 5K. Mr. Seaman noted that a police officer will be going door to door in The Enclave and Thornbrooke to inform our senior citizens.

Mr. Seaman also noted that the FEMA Non-Federal Cost Share application had been submitted for Superstorm Sandy. He noted that department budget worksheets were provided this week to the department heads. Mr. Seaman updated the Council on the Oceanport court shared service agreement and stated that they will also be sharing a street sweeper with them once it is purchased in 2017. The Council discussed the Oceanport agreement.

Reports of Council

<u>Councilman Anderson</u> reported on the Shrewsbury Borough School Board of Education meeting where they discussed a Special Election to handle several options on a proposed referendum. He shared information about the referendum with the Council and reviewed each question that would be on the ballot. The Council and Mr. Seaman discussed the finances that are involved with this referendum and how the Borough is only a collection agency for the school. They also noted that the Special Election to handle the referendum vote was being scheduled for December 13th from 2 to 9 pm.

Councilman Anderson said that he attended the Red Bank Regional High School Board of Education meeting. He also reported on the recent PBA fundraiser.

<u>Councilman DeSalvo</u> reported that the basketball courts are progressing. He stated that the Board of Health held a meeting on Zika last week and the Community Alliance's Red Ribbon Week is currently ongoing at the school.

<u>Councilman Eddy</u> reported on the Shrewsbury Foundation's 5K which was coming up. He also informed the Council that the Borough needs to buy a new postage machine and Mr. Seaman explained the process that was taken to research the new machine. *Councilman Eddy motioned to purchase a new postage machine not to exceed \$3,002, seconded by Councilman Moran, and approved by the following vote:*

<u>Councilman Moran</u> reported that DPW is continuing brush collection, park maintenance, in addition to listing everything they had completed.
